

In consideration of the acceptance of my application to participate in the and with an understanding that there are risks inherent in sailboat racing, I do for myself, my personal representatives, family, heirs and assigns, waive all claim against and release and discharge the Boston Harbor Rhodes 19 Inc and Cottage Park Yacht Club Inc (Further known as the "Hosts"), the host organizations and other sponsoring yacht clubs, their respective officials, directors, agents, members, employees, servants and race committee personnel from any and all claims, demands, liability, causes of action and damage of any nature whatsoever, as may accrue both now and in the future arising out of the participation of the above entry in any activity of the above event.

Further, I hereby represent and warrant that the above entry in the above event will be outfitted, crewed, equipped and handled in such a fashion as to be safe and seaworthy, that the above entry will have all necessary equipment on board and that it will be competently manned and skippered. I further acknowledge that the decision whether to race or to continue to race, rests solely exclusively and finally with the owner and the skipper. I agree to be bound by The Racing Rules of Sailing and by all other rules that govern this event.

Each boat owner and crew member acknowledges that he or she participates in the Rhodes 19 East Coast Championship at his or her own risk (see RRS 4, Decision to Race), and warrants and represents that he or she will comply with all applicable rules and regulations of the Hosts and any applicable state and federal laws. Each boat owner and crew member agree to grant Hosts a waiver of any loss or liability arising from participation by the boat owner and crew member in any Event prior to, during, or after said Event.

The undersigned acknowledges that in consideration of the efforts of the host organization(s), for being allowed to participate in this regatta/races and the acceptance of this application to race, HE/SHE DOES HEREBY WAIVE AND RELEASE ANY AND ALL CLAIMS THE UNDERSIGNED MAY HAVE AGAINST THE HOSTS, THEIR OFFICERS, TRUSTEES AND COMMITTEE MEMBERS, MEASURERS, JUDGES, AGENTS AND REPRESENTATIVES ARISING OUT OF THE ACTIVITIES REQUIRED FOR THE RACES ON THE WATER, AND DOES FURTHER COVENANT AND AGREE NOT TO SUE OR TO BRING ANY CLAIM OR CLAIMS OF ANY NATURE WHATSOEVER AGAINST THE HOST ORGANIZATION(S) OR ANY OF THE PERSONS AND OFFICERS NAMED, OR UNNAMED, ABOVE WHO MAY BE ACTING ON THE HOSTS\' BEHALF.
